Frequently Asked Questions

How do I pay in my fundraising?

There are several ways you can pay in your fundraising. The easiest way is to make a donation online to your fundraising page using a credit or debit card. You can also make a direct bank transfer. Or you can send a cheque made payable to Save the Children to us at Mindfulness Month, Save the Children, 33 Lincoln Square South, Carlton VIC 3053. Remember to write your postcode, group name and reference number on the back of all cheques. Due to current delays with postal systems, please consider making your gift online.

Please don't send cash in the post. To be eligible for the Peppa Mindfulness Top 10 Fundraisers prize, your donations must be made on your fundraising page by 11.59pm on Sunday 31 October.

How do I set up an online fundraising page?

Set up your online fundraising page at www.peppasmindfulnessmonth.com.au. Once you've set up your page, you can use your own personal link to spread the word, and get friends and family to sponsor you.

How do I donate via bank deposit?

You can make a donation by including "PMM2021" in the reference and sending an email to events@savethechildren.org.au letting us know your name and amount raised so we can keep an eye out for the donation!

Can I pay in over the phone?

Yes! You can pay in over the phone by contacting your Supporter Care team on 1800 76 00 11. Please let them know your name and email so they can easily find you in the database and make a record of your donation - don't worry, your details are kept private!

Are donations tax-deductible?

Donations over \$2 are tax deductible. We'll send a receipt soon after a donation is made.

When will I receive my fundraising prize pack?

What if I can't join in October?
