What is Workplace Giving?

Workplace Giving is the process of making regular, tax-deductible donations to Save the Children through your payroll.

Why is your donation so important?

Your donation can help provide better healthcare, a quality education for all children, protection from violence, and safety during emergencies.

Regular donations are vital for us to continue working in some of the most remote and rural communities.

No matter how small, your donation every week or month will make a real impact.

Support children here at home



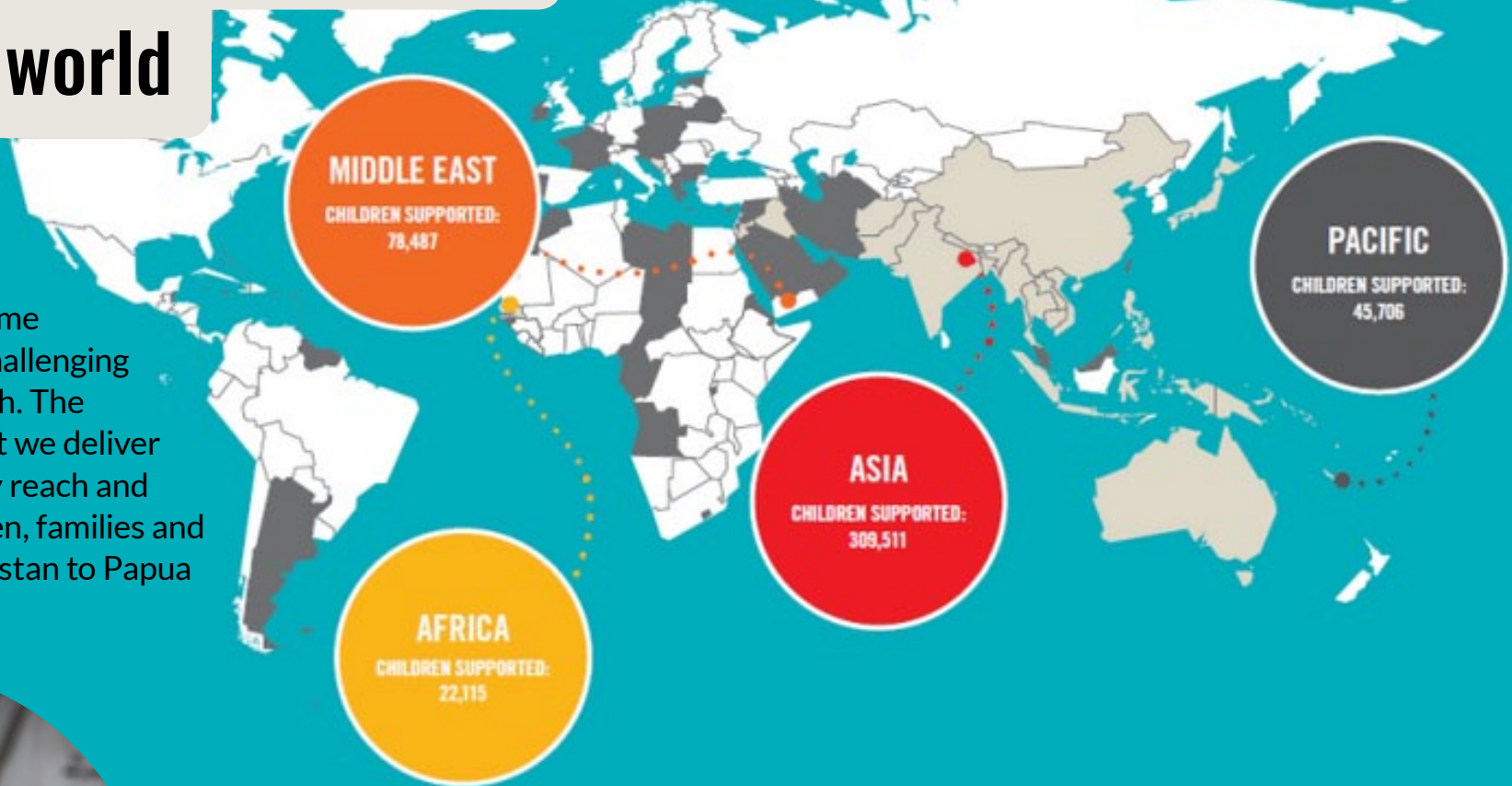
We work in over 200 locations across remote, rural and metropolitan Australia delivering services to vulnerable children and young people.

We work with Aboriginal and Torres Strait Islander children, families and communities, bringing optimism and opportunity, so each child can reach their potential.

We understand that every community has its own challenges, so we use local people to lead culturally safe solutions. We up-skill parents to protect their children, work with children to enhance their wellbeing and development, and support young people to reach their potential.

Protect the most vulnerable around the world

We provide lifesaving support and lifechanging education to children in some of the most isolated and challenging places to be a child on earth. The services and programs that we deliver beyond our shores directly reach and improve the lives of children, families and communities from Afghanistan to Papua New Guinea.



- 10-year-old Aabhas and his 5-year-old brother Cachi, escaped as conflict drew near, fearing for their lives and seeing their home destroyed as they left.
- On the day Save the Children visited, it had been three days since the children had eaten anything apart from bread.
- Save the Children is distributing warm clothing, household items, food and fuel to help displaced families like theirs survive the winter months.

Save lives in emergencies

Save the Children Australia is among the first on the ground when disasters strike. We were there to support children in Australia's Black Summer Bushfires and the floods that followed, we are there on the ground in the midst of the conflicts in Afghanistan and Ukraine, and whenever a Tropical Cyclone batters our neighbours in the Pacific.



Our specially trained teams can act with 72 hours of a disaster to deliver immediate relief and lifesaving supplies.



We provide healthcare, food, clean water and shelter, and reunite children with families if they are separated by the chaos.



We stay on after the TV cameras have gone, helping children recover in the long-term with psychosocial support, educational programs and by rebuilding schools to make sure no child is left behind.

- ✓ By donating from your pre-tax salary, you'll automatically receive your tax deduction for your donation up front. So no need to keep receipts to claim it back come tax time.
- ✓ Your Payroll Team will simply provide a statement of your year's donations along with your Group Certificate at the end of the financial year.
- ✓ It's cost-effective and efficient - by donating from your pre-tax salary it costs you less to give Save the Children more.

HERE'S HOW IT WORKS:



You donate \$5
from your pre-tax
salary



It costs you just \$3.50*
as you receive your tax
deduction up front



But Save the Children receives
the full \$5 to directly support
children in need.

* Exact figure is dependent on the individual's ATO personal tax bracket.



It's easy to get started

You choose how much you want to donate from each payslip.

\$15 a fortnight

can help save a malnourished child by covering their full medical fees.

\$10 a week

can help provide 3 books for a child who doesn't have access to reading materials

The equivalent cost of a coffee a week (\$5)

can help feed a starving child for two weeks with nutritious peanut paste

TWO WAYS TO SIGN UP

- 1 Ask your Payroll Team if they already have a Workplace Giving Form they can send to you and simply nominate Save the Children.
- 2 Or simply complete the Workplace Giving Authorisation form provided by Save the Children and send it to the Payroll Team at your workplace.
